- Earned Income Credit could be worth up to \$5,891 for 2012, depending on filing status, income, and number of qualifying children.
- You can deduct your contributions to charitable (non-profit) organizations only if you itemize your deductions.
- Deduct unreimbursed business expenses if you itemize your deductions and the total of your employee business expenses is more than 2% of your adjusted gross income.
